Update on Board Reappointments/ Appointments Karla has been discussing the open board positions with the Commissioners. Ray said that this coming Tuesday they will be reappointing Matt, Rhonda, and Shell to the board. They want a selection of candidates for the open seats. They will advertise for more candidates. It is there right and authority to ask that. We will also share the link for the application. Currently, the link is incorrect. We don't know the criteria that the Commissioners are vetting people on. Beth has agreed to stay on until she is replaced. Jeanne couldn't stay for health reasons. In twelve months, Ken will be completing his second term and Dale will be completing his first. We are an independent organization. The commissioners give us a large portion of our money, but they do not control us.

Karla is considering proposing associate board members. They wouldn't be a voting member, but they would be familiar with the organization and be able to step into full board membership.

Dale commented that our lease will be expiring and recommends that Karla finds a real estate consultant. Many factors will come into play. Matt said that we don't need to make a long-term commitment. High has already approached Karla about renewing the lease. Karla has had experience in relocating a library business. In a past case, it was advantageous to purchase a property. If we are in a role as the district for the long term it would be advantageous to move. If we move to a free and reduced lunch rate school area our erate would be considerably more. January of 2022 our software is up for renewal. Big decisions will need to be made in the next year or two. It is a smart strategy to be transparent with High. Hopefully they will let us renew for a short term.
